NOTIFICATION

Pursuant to the approval of the Competent Authority, the Service Recruitment & Promotion Rules, 2013 of NCCT have been amended as under:

- i) The essential educational qualifications for the post of Audit Officer, NCCT HQ and Accounts Officer, VAMNICOM, Pune has been revised to Chartered Accountant (CA)/ Cost and Management Accountant (CMA). All other qualifications viz. MBA (Finance) or equivalent or Post-Graduation with 55% marks in Commerce/Economics mentioned in the existing Recruitment Rules, 2013 for these posts stands removed forthwith.
- ii) The Selection method will be applicable for promotion to Group 'A' category posts only, as per criteria given below:

S.No.	Factors	Marks
1	Benchmark obtained in APAR Grading in 5 years reckoning period.	30
2.	Entire Service Record	30
3.	Interview*	40

(*) The DPC will conduct the interview and make the assessment out of the assigned weightage of 40 marks. The DPC will also make the overall assessment as per above mentioned parameters.

- (a) Thereafter, the DPC will recommend the candidate "fit" and "unfit" for promotion to the higher post on the basis of the overall assessment of the candidates to be carried out on above parameters. The candidates securing less than 70% marks will be declared "unfit" for promotion for that selection cycle.
- (b) A relaxation of 10% in minimum percentage for reserved category like SC, ST, PwD and Women will be given if the DPC feels that there is no proper representation from the above said reserved category in the list of Selected Candidates.

- (c) For the purpose of Interview, all the candidates in the Zone of Consideration will be called.
- (d) The Inter-se Seniority of the selected candidates will remain intact.

This notification is effective immediately.
